You must become a Member of the Pinto Horse and Pony Association Inc. to register a horse or pony. Forms are available from the secretary or printable from the website.

HORSES & PONIES UNDER THE AGE OF 2 YEARS AND OLDER

All horses and ponies must apply for registration by mail to the Committee.

Registration is processed by photo assessment - six photos must accompany the application.

Photo one: Must be of the right side of the animal, the complete animal must be visible.

Photo two: Must be of the left side of the animal, the complete animal must be visible.

Photo three: Must be taken directly in front of the animal and must include the complete animal from ears to toes. Whole hooves must be visible.

Photo four: Must be taken directly from the rear of the animal and must be of the complete animal from rump to heels.

Photo five: Must be another right side of the animal (not a duplicate photo) the complete animal in the photo must be visible.

Photo six: Must be another left side of the animal (not a duplicate photo) the complete animal in the photo must be visible.

If your horse or pony is registered with any other association a copy of the breed association certificate or service certificate is also required with your application.

STALLIONS

Stallions must apply for registration by mail to the Committee. A current Veterinary Certificate of soundness and six photos as above must accompany the application. A copy of the registration certificate from its respective breed association must accompany the registration (if applicable) and with the respective fee included. Owners are to be financial members of the PHPA Inc.

MARES & GELDINGS

Mares and Geldings must apply for registration by mail to the Committee and six photos as above must accompany the application. A copy of registration certificate from its respective breed association must accompany the registration (If applicable) also with the respective fee. Owners are to be financial members of the PHPA Inc.

HORSES & PONIES UNDER THE AGE OF 2 YEARS

COLT/FILLY FOAL RECORDING

Foal Recording must apply for registration by mail to the Committee. Six photos as above must accompany the application. A copy of service certificate of proof of mating or copy of registration certificate from its respective breed association must accompany the registration (If Applicable) with a fee of \$20.00. Owners are to be financial members of the PHPA Inc.

UPGRADE OF REGISTRATION

All Colt/Filly Foal recorded registrations must be upgraded to adult registration before obtaining the age of 4 years. Colts being upgraded to Stallion status must send in a current Veterinary Certificate of Soundness, six new photos with two photos signed by Veterinary Surgeon, return foal registration papers and include the upgrade fee of \$115.00.

Colts which are gelded - must also send in a copy of the Veterinary Certificate stating gelding date, six new photos, and return their Colt registration papers to the association with the upgrade form and fee of \$20.00.

Fillies upgraded to Mare – please return foal registration paperwork with upgrade form and fee of \$35.00

New Adult certificates will be issued after all fees & paperwork is submitted to the Registrar.
